COURSES: The UW-Parkside course is the site many major events every fall. The Foot Locker Cross Country Midwest Regional will be held on the UWP XC course on November 28th

TEAM COMPETITION: The top five (5) individual finishers from Illinois and Wisconsin in the High School Boys & Girls races constitute each state's team. The scoring system is based on the total points of these 5 finishers from each state.

STATE SINGLETs: State singlets will be given to all entrants registered on or before Monday, November 9th. Late registrants will receive singlets with the supply lasts.

AWARDS: Medals will be presented to the top five M&F WI & IL finishers in the high school races. Medals will be given to the top five M&F in the 12 & U 3K. Medals go to the top three M&F in the Open (Under 40) & Master's (40+) divisions of the Open Race.
