HS COURSE: We will run the JR 5km COURSE, the course that runs to the NORTH SIDE of the Facility.

MEET CHECK-IN ON ARRIVAL: Eagle Invite coaches check in at the finish line building/tent.

AWARDS: VARSITY MEDALS to the Top 40 Finishers. JV MEDALS to the Top 10 Finishers. Team Awards to Varsity 1st and 2nd Place Teams. There will not be a Formal Award Ceremony, teams or individuals may pick up their awards near the Finish Line House.

TEAM CAMPS - TENTS & GROUND TARPS are allowed. This is where athletes leave their gear bags and water bottles. THIS IS A TEAM AREA for only Athletes and Coaches. Parents and Spectators are not allowed in this area. Advise your parents to meet their athlete outside of this area.

PARKING:

UW-P Parking Lots --- All teams & spectators should come in on Highway E and then turn onto Highway JR to access the UW- Parkside parking lots east of the course. There is no participant drop off on Highway JR. There is no fee for parking.

No parking allowed in any of the Petrifying Springs Park parking lots - this includes teams, coaches and spectators. The Kenosha County Sheriff Department has been and MAY be ticketing anyone violating this policy! Please inform your fans of this information as well.

Handicap Parking (with Permit) is allowed in the Parking Lot immediately North of the course on Highway JR.

**** CONCESSIONS:** The UW-Parkside XC and T&F team will be operating a concession stand on the course throughout the day.

**** EVENT T-SHIRTS** will be available and a PRE ORDER FORM will be made available mid September.

**** NO DOGS and NO DRONES are allowed at UW-Parkside before, during or after the Meet.**

**** ADMISSION:** The admission fee per spectator is \$4.00 for 17 & Under and Seniors and \$6.00 for Adults (18 & over).
