**PARKING**: All buses, team vehicles and spectators should come in on Hwy E and turn onto Hwy JR to access the UW Parkside Parking Areas (down the hill to the Communication Arts Lot). There will be no drop off on Hwy JR to the course. No parking is allowed in any of the Petrifying Springs Parking Lots, this includes team buses or vehicles, coaches and spectators. The Kenosha County Sheriff does patrol the area and you may be ticketed for violating the policy. HANDICAP PARKING is available across from the entrance to the course, make certain to have a Handicap Plate or Permit for the officers to see and allow vehicles to enter.

**TEAM TENTS**: No team tents or team camps are to be set up in Petrifyting Springs Park. You must headquarter your team on the UW Parkside Course in the designated are behind the Finish Line. Only coaches and team members, finish line help will be allowed in the tent/team camp area. No parents and other spectators will be allowed in the area. We realize some teams rely on parents to transport and set up their team tents, it is acceptable for them to do so at Sectionals.

Please remember that it is prohibited to mark the course in any manner, including paint, streamers, signage, etc. A digital display clock will be used as a countdown for each race and one will be provided for splits at the 1 mile, 2 mile, and 3 mile mark. There will be timing mats at 1 mile and 2 mile as well and LIVE RESULTS will be available on the Wisconsin Runner site.

ONCE THE GIRLS RACE HAS BEGUN, warmups on the course are limited to following the race in progress. Team may not warmup "randomly" on the course while the girls race is in progress.

**STARTING LINE**: Only a teams 7 competing members, one alternate, and two coaches are allowed in the designated starting area. Coaches will be given access passes at packet pickup
